WE ALSO ASSIST WITH PAST-DUE UTILITIES TO PREVENT UNSAFE LIVING CONDITIONS AND POSSIBLE EVICTION. DAYSTAR IS A SECURE MAIL SITE FOR OUR CLIENTS WHO ARE HOMELESS, UNSTABLY HOUSED, OR FEAR MAIL THEFT. WE HELP STRANDED HOMELESS CLIENTS THROUGH OUR PARTNERSHIP WITH TRAVELER'S AID INTERNATIONAL. CLIENTS HAVE ACCESS TO COMPUTERS, THE INTERNET, PHONES, AND CELL PHONE CHARGING IN OUR RESOURCE ROOM.

ONSITE COMMUNITY PARTNER SERVICES: THE PINELLAS COUNTY DEPARTMENT OF HEALTH, A BAYCARE FAITH COMMUNITY NURSE, AND OTHER COMMUNITY AGENCIES ARE REGULARLY ONSITE AT DAYSTAR TO OFFER HEALTH SCREENINGS, PREVENTION SERVICES, BASIC MEDICAL AND DENTAL CARE, AND VACCINES. HEALTHCARE NAVIGATORS HELP CLIENTS FIND HEALTH COVERAGE THROUGH MEDICAID, MEDICARE, AND THE MARKETPLACE. THE FLORIDA LICENSING ON WHEELS VAN VISITS MONTHLY TO ISSUE FLORIDA IDENTIFICATION.
